Mr. Dugan also received a letter from Dr. Beth Purvis on behalf of Gov. Rauner in response to the budget impasse letter Mr. Dugan had sent previously. However, at this time the "stop gap budget" was already in place by the time the letter was written and received.

Agenda Discussion Items:

- a) <u>Award of Monsanto Grant "Space Maker:</u> At this time Mr. Jeff Hall and Ms. Anna Janssen from Monsanto represented the New Holland-Middletown Board of Education and Superintendent Dugan with a \$9,000.00 Grant for the schools, "Maker Space" to be located in the junior high school side of the building.
- b) <u>Board Policies 2:70, 6:100, 6:235, 7:10, 7:270, 7:340, 8:90 and 8:110 (1st Reading):</u> Superintendent Dugan went over all of the new board policies including but not limited to; Vacancies on the School Board, Animals & Animal Dissection, Access to Electronics, Equal Education Opportunities, Administering Medicine, Student Records, Parent Organizations and Booster Clubs, Public Suggestions and Concerns...If anyone has any questions, please feel free to ask Mr. Dugan.
- c) Phyllis J. Blaum Memorial Music Fund: Superintendent Dugan spoke with Wendy Custis via telephone regarding the concerns from the July meeting. The word "scholarship" was dismissed and the new name/line item in the Activity Fund will now be called the "Blaum Memorial Music Fund". The Music Teacher will be allowed to use this fund for music purposes of any kind. At this time, a donation from the Blaum/Custis Family in the amount of \$5,050.00 was received by the school. The Board and Mr. Dugan were very appreciative of this donation.
- d) <u>Transportation Options Fiscal Year 2017:</u> The Board of Education has decided to keep the schools' current van for transportation another year or so, since maintenance was just completed within the year.
- e) <u>Cleanup Estimate-Network Hub Area:</u> The new estimate which was received from Talley Technical Services (TTS) is much cheaper than received previously. The conduit will be shortened and the rack will still be seen, but the area will be cleaned up and have a much better appearance.
- f) <u>Display of FY2017 Budget:</u> This will be on display for 30 days in the school office. The budget is balanced by a considerable amount even though there is a large transfer from the ED Fund to the HLS Fund for repairs for the school.
- g) <u>ISAL IV Application:</u> Superintendent Dugan was nominated for the 2 year in a row to attend this intense course conference with other superintendents to learn and share about Leadership Practices.
- h) <u>FOIA Request from One Chance Illinois:</u> Mr. Dugan sent the requested information for the FOIA to requestee Mr. Colin Driehorst, Policy Associate, One Chance Illinois.
